# REA<sup>3</sup>D Helps Proctor Middle School "Ramp Up to Readiness"

As part of a college and career readiness program in the Proctor School District called Ramp Up to Readiness, REA<sup>3</sup>D sponsored college visits for middle school students. They took a field trip to either the University of MN Duluth or Lake Superior College. This project made an effort to put Proctor students on a trajectory for life after high school and excite them about the opportunities they have.

Students spent the year learning about their various learning styles and thinking about a field of study they would be interested in pursuing after high school. During the college visit they were split into groups of ten. They toured the schools that had their areas of interest. They spent the day experiencing college life.

After their college visits, many reported having a greater interest in continuing their education in college after high school.

# Marco-Polo: GPSs in the Bay View School Forest

With the help of a grant from REA<sup>3</sup>D, Bay View students will no longer get lost in the woods. Dean of Students at Bay View, Jim Conrad, applied for a grant early last fall to receive GPS units for student use in the school's forest. They were used throughout the school year by classroom teachers and students. They were also used during the school's afterschool Forest Club Program led and taught by Deb Richards. Students used them for simple activities, and were taught how to use them for adventurous activities like Geocaching.





Geocaching is an outdoor recreational activity. Participants use a Global Positioning System (GPS) unit and other navigational techniques to hide and seek containers, called "geocaches" or "caches," anywhere in the world. The caches will have little prizes in them for people to find or bring the seeker to a space of beautiful scenery. Caches are hidden throughout the Bay View School Forest and can be found by anyone. It is common that if one finds a Cache, s/he replaces its contents with something else.



#### Auction Makes a Comeback—Sherman Carlson

As the event came to a close around noon on that Saturday morning, even the most optimistic prognosticators smiled with embarrassment. Who would have thought that those present just witnessed the single greatest fund-raising event for REA3D in its 18-year history.

Modeled after a similar event back in the 1980s, which helped jump-start the creation of the Terry Egerdahl Memorial football field, the question was raised as to whether the public might again be receptive to a community auction.

From the start, "the stars seemed to be aligned." When Forrest Evavold, owner of Nordic Auction, was asked what his commission would be if hired to conduct the event, he responded "nothing." Nothing! He and his staff would be pleased to donate their services (REA³D being a non-profit) and all measures validating the bidding process.

Early on, other local businesses offered support services by donating storage space, rental chairs, vehicle and trailer transporting...and significant publicizing by the Proctor Journal with full-page ads, listing each item (with description) slated for sale.

The week before the event, the array of items was beyond imagination! Boats, motors, generators...house wares, artworks of every description...power tools, shotguns, outdoor equipment, sporting goods...musical instruments, antiques, gift certificates...and even a car would bring down the auctioneer's gavel.

All total, over a 150 articles were previewed an hour before the live event commenced, donated by more than 90 businesses and individuals. By morning's end, not one item remained on the athletic floor.

"This is probably one of the best organized auctions I've been involved with over the years," commented Evavold, "and one of the best collection of articles I've observed."

Those REA<sup>3</sup>D members present offered guesses on the total dollars raised...most guessed in the \$5,000-\$7,000 range. Banded around the cash and checks was the final accounting tape revealing the final figure...over \$10,500.



# Tasting Event a Success—Lynn Peterson

The REA<sup>3</sup>D Foundation has hosted a variety of events, mixing food with fundraising. Over the years, the committee has tried to appeal to a variety of audiences. For several years, a candlelit dinner was held at Blackwoods in the winter or early spring, a circus-themed hors d'oeuvres spring event was held at Spirit Mountain, and a barbecue summer-themed event was held on the Sundew. This fall, the committee decided to host a tasting event with its theme *Tracking Future Success – a Tasting Event to Support REA*<sup>3</sup>D. Food vendors who participated in the event included Pelican Coffee in Hermantown, Thirsty Pagan in Superior, Jim and Jo's Café in Cloquet, Zen House in Hermantown, Famous Dave's in Duluth, GB Schneider's in Duluth, The Duluth Grill in Duluth, and Proctor High School's Culinary Class. Beverage vendors included Super One



Liquors and Bent Paddle Brewing. Those who attended feasted on a variety of restaurant specialties including pasta with tomato basil sauce, sushi rolls, lobster stuffed puffs, pizza, bruschetta, bread pudding, egg rolls, roll-ups, sandwiches, and mini cupcakes and pies. For a \$20.00 bill, everyone who attended left satiated and satisfied.

The silent auction also delighted attendees with baskets including a wine and pasta basket, a book lover's basket, a children's playtime basket, a kitchen basket, Bentleyville sweatshirts and basketball basket, an original painting from Barb Steen, and an athletic basket from Austin Jarrow. Surprises in the baskets also included gift certificates to Grandma's restaurant and the Scenic Café. Ken Buehler, long-time REA³D supporter and emcee for the evening, generously donated a birthday train ride and an adult cocktail party. The total funds raised for the evening were over \$3,000. It was an unforgettable evening.


